
[Vaccine Exemption Guide](#) Keep in mind - quitting your job releases your company of any liability and essentially places all of the burden on you. Also, refusing the vaccine is an easy way to become a target - consider “deferring your acceptance of the vaccine” instead. And yes, you can defer indefinitely!

Federal Mandate: The [Executive Order mandating all federal employees and contractors to receive the Covid-19 vaccination](#) was signed by Joseph Biden in September of 2021. This executive order has called into question the constitutionality and legality of such a mandate placing federal employers and employees in a precarious position. The mandate clearly states in section 4 (c) “This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person” essentially placing the burden of enforcement on the employers; many of which are being threatened with loss of federal contracts should their workforce fail to comply. The definition of coercion is the practice of persuading someone to do something by using force or threats. Now, many are facing a slew of immoral actions including rejection of reasonable accommodations, denial of religious exemptions regardless of their sincerely held religious beliefs, denial of medical exemptions, and termination due to “non-compliance”.



The Results: (Unofficial) **Russel Stall (D-incumbent): 3,880 Joe Farmer (R): 2,699**



Parliamentarian's Perspective


In an attempt to promote education and simplification of what tends to be a complex process, we will hear periodically from our Parliamentarians regarding processes commonly experienced by the body.

The Quorum

The concept of the quorum is to ensure a significant number of members participate in the business of the organization. This is done to avoid a small group within the organization hi-jacking it and redirecting the organization or misusing its assets. The actual percentage of the members of an organization needed for a quorum is set in the organization's rules. In our case the requirements for quorum are found in Rule 5 Quorum.

Early in every GCGOP meeting the Credentials Committee reports on how many precincts are represented at that meeting. This is to demonstrate to the body whether a quorum exists. Throughout the meeting, the Credentials Committee checks who is leaving the meeting to verify a quorum remains.

For a regular GCGOP meeting, a quorum exists when 25 members or one third or more of the organized precincts are represented at the meeting. For some actions that are identified in the GCGOP Rules, a larger percentage is needed. See Rule 2 Amendments.
